  - a. Questions
    - i. Multiple nominees may make it to the Regents. Can there be more than one in a given year?
      - a. Yes, there could be more than one.
    - ii. Must have five years of tenure track service.
      - a. Language is confusing. Should be someone who served at MSU for over five years in a tenure track line.
        - i. Language should be clarified.
    - iii. Workload and expected activities. Nothing talks about alternative duties that comes with this. It should be clear.
      - a. There is a stipend.
      - b. Language says, “expected activity.” Marg Hammersla will work on some alternative wording.
    - iv. How frequently do we take nominations to the Regents?
      - a. Usually one or two a year, but no one has been nominated in some time.
    - v. How many do they have at UM?
      - a. They made a nomination at the last BOR meeting. One retired last year. Not sure of the count currently.
