References made below to the Project Manual and Drawings shall be used as a general guide only. Bidder shall determine the extent of work affected by Addendum items.

# GENERAL NOTES:

- 1. Bids are due **November 12, 2025** at **2:00 pm**. Please review project manual for full details.
- 2. MSU has requested that the selected contractor provide a number for and be ready to move/relocate the white drive under bin located on the north side of the mill. MSU is currently constructing a pad near the site for the final location for the bin.
- 3. Contractor will be responsible for coordinating the work limits boundary with Project Coordinator, Kellen Marlow. Kellen will set limits for MSU students.

### **QUESTIONS (Q) / CLARIFICATIONS (C):**

- Q1. Who is responsible for electrical disconnection/de-energizing the power pole on the project?
  - C1. Montana State University owns the power at this location and will disconnect all power to the Feed Mill prior to demolition. All building demolition including electrical items will be by awarded contractor. MSU will also verify/remove any power to the hay sheds, if any.
- Q2. Has there been an asbestos inspection of the BART Farm Demolition and if so, is the report available?
  - C2. MSU Facilities has reviewed the site for ACM and had requested that the grain legs be disassembled in sections, lowered to the ground and wipe tested prior to hauling away. It has been decided at the pre-bid walk through meeting that grain legs will be wiped tested PRIOR to any disassembly. An asbestos inspection report has not been undertaken. MSU requests that this be handled by the selected contractor.
